



# HOE BEMAAK EK 'N ERFLATING AAN AFRIFORUM?

AfriForum is afhanklik van ledegeld, skenkings, erflatings en ander bydraes deur sy ondersteuners om sy visie, missie en ander doelstellings tot voordeel van die breër gemeenskap te bereik. Baie van AfriForum se lede en ondersteuners koester die begeerte om AfriForum as begunstigde in hul testament te benoem, maar is nie altyd seker hoe om te werk te gaan nie. In ander gevalle het die testateur nie die nodige inligting oor AfriForum om die erflating in die testament te laat verwesenlik nie.

- 1) Wanneer 'n testament opgestel of gewysig word, is dit belangrik om die erfgenaam se volle besonderhede te hê, veral as die erfgenaam 'n maatskappy is – soos AfriForum. AfriForum se volle besonderhede vir dié doeleindes is:

- 2) Die eksekuteur (dit is die persoon wat die boedel beredder) kan dan die bogenoemde inligting gebruik om AfriForum te kontak om verdere inligting te bekom.
- 3) Sommige lede of ondersteuners wil graag alternatiewelik of bykomend tot 'n geldelike bemaking ander roerende of selfs onroerende bates aan AfriForum bemaak. Dit sluit voertuie, waentjies, brandkarre, huise, woonstelle en dies meer in. Dié lede of ondersteuners is dan nie seker of hulle dit wel kan doen nie. AfriForum sal met groot dankbaarheid hierdie tipe bemakings aanvaar.
- 4) Indien AfriForum as erfgenaam in 'n testament benoem word en die boedel word vasgevang in litigasie, 'n familietwis of enige ander hindernis, sal AfriForum nie betrokke kan raak by sulke gevalle as party of namens die boedel nie. AfriForum kan ook nie betrokke raak by die bereddering van die boedel nie, buiten om as erfgenaam van tyd tot tyd te help navraag doen nie.

# HOW DO I BEQUEATH A BEQUEST TO AFRIFORUM?

AfriForum is dependent on membership fees, bequests, donations and other contributions from its supporters to realise its vision, mission and other goals to the benefit of the broader community. Many AfriForum members or supporters want to nominate AfriForum as beneficiary in their last wills and testaments, but they are not always sure exactly how to go about doing so. In other cases, the testator does not have the required information about AfriForum to be able to give effect to the bequest in the last will and testament.

- 1) When you draw up or change your last will and testament, it is important to always give the heir's full details, especially in the case of a company, such as AfriForum. AfriForum's full details for this purpose are:

- 2) The executor (this is the person who administers the estate) can then use the above information to contact AfriForum to obtain more information.
- 3) In addition to or as an alternative to a monetary bequest, some members or supporters want to bequeath moveable or immovable assets to AfriForum. These include vehicles, trailers, fire trucks, houses, flats and so forth. These members or supporters are then uncertain of whether they can do this. AfriForum will gratefully accept such bequests.
- 4) If AfriForum is nominated as an heir and the estate gets entangled in litigation, a family feud or any other obstacle, AfriForum will not be able to become involved in such cases as a party or on behalf of the estate; neither can AfriForum become involved in the administration of the estate, except to make enquiries from time to time in its capacity as heir.
